## Contest Rules:

1. Age limits are 13 through 21, inclusive as of September 10, 2010.
2. This contest is not open to professionals. Professional is defined as anyone who is a member of a performers union, has a professional manager, or their supporting income is derived from performing (1/2 of his/her normal living expenses).
3. Entries will be accepted in the following categories:
  - Vocal Solo
  - Vocal Group (10 or less)
  - Instrumental Solo
  - Band (7 or less)
  - Dance Solo
  - Dance Group (10 or less)
  - Variety (5 or less)
4. This contest is not open to baton twirlers, machete acts or any acts using fire.
5. In any vocal category, instrumental accompaniment by the persons in the act or others is allowed, but must assume pure character of accompaniment. The test shall be whether the performance could stand alone if the accompaniment were removed. NO VOICE/VOICES ON ACCOMPANIMENT TRACKS RESEMBLING VOCAL UTTERANCES OR BACKGROUND SINGING MAY BE USED FOR ACCOMPANIMENT BY CONTESTANTS IN THE VOCAL CATEGORY.
6. In an instrumental solo, accompaniment is allowed, but must assume the pure character of accompaniment. No instrument of the same nature may be used for the accompaniment.
7. IMPORTANT: Music for accompaniment must be of the highest quality. Always bring a back up CD.
8. In a group act, all persons assuming visual importance in the act must meet the age qualifications of the Appalachian Fair Youth Talent contest.
9. Any act may drop a member as listed on the entry form, but a member may not be added or replace any member listed on the original entry form.

10. It is recommended that an act should not run more than 3 minutes and under no circumstances can the act exceed 4 minutes. Acts will be disqualified if they exceed 4 minutes. An official timer will be present at the audition and during the Fair contest.
11. All contestants will use only the lighting system as provided by the Fair.
12. All contestants, excluding bands, will use only the sound system and sound operator as provided by the Fair. Bands may use their own amps.
13. Teachers nor parents are allowed on stage during the Fair contest.
14. Only one person will be allowed backstage with each act.
15. Contestant's eligibility will be left to the discretion of the contest committee. Their decision is final. Previous first place winners may not compete in subsequent years. Depending on the number of entries, a preliminary audition may be held. You will be notified of the time and place for the preliminary audition by August 1, 2010.

Winners in the Appalachian Fair Youth Talent Contest are eligible to enter the Tennessee Valley Regional Youth Talent Contest. The first place winner is guaranteed an invitation to this event.
